In addition to the elections there were legislative matters in the current session that were addressed concerning Sheriffs and Deputy Sheriffs. The DSAP is requesting our membership to contact your state representatives asking their support for House Bill 1303, Printers No. 1739. This bill would amend the statute to include Sheriffs and Deputy Sheriffs under the Body Cam Act. HB 1303 is currently assigned to the Judiciary Committee. There was also discussion on Senate Resolution 172, Printers No. 1225 that establishes a task force on LE practices and procedures in response to demonstrations, protests and civil disobedience. Sheriffs are not included in the resolution and for that reason we oppose the passage or movement until SR 172 is amended. It is incomprehensible that representatives of The Office of the Sheriff are excluded from this task force. We as Deputies have just as much, if not more, interaction and experience in acts that threaten our citizens and property than many of our brothers and sisters in the law enforcement profession. In the event of any court order or injunction in such matters it is the duty and responsibility of the Sheriff to enforce. We urge all of you to contact your State Senator to voice your concerns.

The DSAP encourages all deputies to be become involved in our association. Your input is valuable regardless of the county you serve.
